(1) 準買家應參閱發展項目的售樓說明書，以了解該項目的資料。

Prospective purchasers are advised to refer to the sales brochure for the Development for information on the Development.

(2) 根據《一手住宅物業銷售條例》第 52(1)條及第 53(2)及(3)條，-

According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

#### 第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5%的臨時訂金。

A Preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a Preliminary Agreement for Sale and Purchase in respect of the specified residential property with the owner.

#### 第 53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an Agreement for Sale and Purchase in respect of the residential property within 5 working days after the date on which the person enters into the Preliminary Agreement for Sale and Purchase, the owner must execute the Agreement for Sale and Purchase within 8 working days after that date.

#### 第 53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an Agreement for Sale and Purchase in respect of the residential property within 5 working days after the date on which the person enters into the Preliminary Agreement for Sale and Purchase- (i) the Preliminary Agreement for Sale and Purchase is terminated;(ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

(3) 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第 8 條及附表二第 2 部的計算得出的。

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

(4) 註: 於本第(4)段內:

- (a) 「賣方」指喜鵲發展有限公司。
- (b) 「售價」指本價單第二部份表中所列住宅物業的售價;
- (c) 「成交金額」指臨時買賣合約及買賣合約(或經修訂的買賣合約)所訂明的住宅物業的實際售價(即售價經計算相關支付條款及適用折扣(如有)後之價目)。因應相關支付條款及適用折扣(如有)按售價計算得出之價目, 皆向下捨入換算至百位數作為成交金額。

- (a) "Vendor" means Ascend Speed Limited.

- (c) "Transaction Price" means the actual purchase price of the residential property set out in the Preliminary Agreement for Sale and Purchase and Agreement for Sale and Purchase (or the amended agreement for sale and purchase), i.e. the purchase price after applying the relevant terms of payment and applicable discount(s) (if any) on the Price. The price obtained after applying the relevant terms of payment and applicable discounts (if any) on the Price will be rounded down to the nearest hundred to determine the Transaction Price.

#### (4)(i) 支付條款 Terms of payment

於簽署臨時買賣合約時, 買方須繳付相等於成交金額的 5%作為臨時訂金。其中港幣\$80,000 作為部分臨時訂金必須以銀行本票支付, 臨時訂金的餘額可以支票及/或銀行本票支付, 本票及支票抬頭請寫『羅文錦律師樓』。

Purchasers shall pay the preliminary deposit (which is equivalent to 5% of Transaction Price) upon signing of the Preliminary Agreement for Sale and Purchase, of which HK\$80,000.00 being part of the Preliminary Deposit must be paid by a cashier order and the balance of the preliminary deposit may be paid by cheque(s) and/or cashier order(s). The cashier order(s) and cheque(s) should be made payable to "Lo & Lo".

95% of the Transaction Price being balance of the Transaction Price shall be paid by the Purchaser within 90 days after signing of the Preliminary Agreement for Sale and Purchase.

##### (b) 180 天付款計劃 180-day Payment Plan

A preliminary deposit equivalent to 5% of Transaction Price shall be paid by the Purchaser upon signing of the Preliminary Agreement for Sale and Purchase.
- (2) 成交金額 95%即成交金額餘款於買方簽署臨時買賣合約後 180 天內支付。  
95% of the Transaction Price being balance of the Transaction Price shall be paid by the Purchaser within 180 days after signing of the Preliminary Agreement for Sale and Purchase.

#### (4)(ii) 售價獲得折扣的基礎 The basis on which any discount on the Price is available

Please refer to paragraph (4)(i).

**(b) 「龍年賀歲」折扣大優惠 #1 “Year of the Dragon Celebration” Promotion Discount Benefit #1**

如買方簽署臨時買賣合約購買任何本價單內所列之住宅物業買方可根據選擇之付款計劃獲得所列出的售價折扣優惠。

If the Purchaser signs the Preliminary Agreement for Sale and Purchase to purchase any of the residential properties listed in this price list, discount on the Price would be offered to the Purchaser according to the selected payment method.

(1) 選擇第(4)(i)(a) 段之付款計劃之買方可獲售價 18%折扣優惠 A discount of 18% would be offered to the Purchaser who selects Payment Plan in paragraph 4(i)(a).

(2) 選擇第(4)(i)(b) 段之付款計劃之買方可獲售價 17%折扣優惠 A discount of 17% would be offered to the Purchaser who selects Payment Plan in paragraph 4(i)(b).

**(c) 「龍年賀歲」折扣大優惠 #2 “Year of the Dragon Celebration” Promotion Discount Benefit #2**

(1) 如買方簽署臨時買賣合約購買 10 樓 A 單位，買方可獲 3.2% 售價折扣優惠。

If the Purchaser signs the Preliminary Agreement for Sale and Purchase to purchase Flat A on 10th floor, a 3.2% discount on the Price would be offered to the Purchaser.

(2) 如買方簽署臨時買賣合約購買 7 樓之 B 單位，買方可獲 3.5% 售價折扣優惠。

If the Purchaser signs the Preliminary Agreement for Sale and Purchase to purchase Flat B on 7th floor, a 3.5% discount on the Price would be offered to the Purchaser.

賣方保留隨時更改或取消此「龍年賀歲」折扣大優惠#1 及「龍年賀歲」折扣大優惠 #2 的絕對權利，恕不另行通知。

The Vendor reserves its absolute right to change or cancel this “Year of the Dragon Celebration” Promotion Discount Benefit #1 and “Year of the Dragon Celebration” Promotion Discount Benefit #2 at any time without further notice.

**(d) 「提前付清餘額現金回贈」優惠 “Early Settlement Cash Rebate” Benefit**

(1) 如買方提前於買賣合約訂明的付款限期日之前付清成交金額餘額，及在所有方面履行和遵守買賣合約內一切的條款及條件，可獲賣方根據以下方式及列表格計算的「提前付清餘額現金回贈」（「現金回贈」）：

Where the Purchaser settles the balance of the Transaction Price earlier than the due date of payment as specified in the agreement for sale and purchase in full and perform and comply with in all respects the terms and conditions thereof, the Purchaser shall be entitled to an “Early Settlement Cash Rebate” (“Cash Rebate”) payable by the Vendor in the amount and manner as set out in the table below:

- (2) 買方須於擬定提前付清成交金額餘額日前最少 28 日，以書面通知賣方向賣方申請「現金回贈」並向賣方提交賣方所要求的一切資料，賣方於收到申請並確認有關資料正確後，「現金回贈」將直接用於支付買方應繳付之部份成交金額餘額。

The Purchaser shall inform and apply to the Vendor in writing for the "Cash Rebate" at least 28 days before the proposed date of early settlement of the balance of the Transaction Price and submit to the Vendor all information as required by the Vendor. After the Vendor has received such application and verified the information, the Vendor will apply the "Cash Rebate" directly as part payment of the balance of the Transaction Price payable by the Purchaser.

- (3) 「提前付清餘額現金回贈」計算得出的金額皆以四捨五入至個位整數。

The amount of "Early Settlement Cash Rebate" will be rounded to the nearest dollar.

- (4) 付清成交金額餘額日期以賣方代表律師收到所有成交金額款項日期為準。如「提前付清餘額現金回贈」列表中訂明的期限的最後一日不是工作日(根據《一手住宅物業銷售條例》第 2(1)條所界定釋義)，則該日定為下一個工作日。

The date of settlement of the balance of the Transaction Price shall be the date on which all the Transaction Price is received by the Vendor's solicitors. If the last day of the period as set out in the "Early Settlement Cash Rebate" table is not a working day (as defined in section 2(1) of the Residential Properties (First-hand Sales) Ordinance, the said day shall fall on the next working day.

**Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property**

- (1) 買賣雙方須各自負責有關臨時買賣合約、買賣合約及轉讓契等法律文件之律師費用。

Each of the Vendor and Purchaser shall pay his own solicitors' legal fees in respect of the Preliminary Agreement for Sale and Purchase, the Agreement for Sale and Purchase, the Assignment, and etc.

- (2) 買方須支付一概有關臨時買賣合約、買賣合約及轉讓契之印花稅(包括但不限於任何買方提名書或轉售的印花稅、額外印花稅、買家印花稅及任何與過期繳付任何印花稅有關的罰款、利息及附加費等)、登記費及其他支出費用。

All stamp duty, registration fee and other disbursements on the Preliminary Agreement for Sale and Purchase, the Agreement for Sale and Purchase and the Assignment (including without limitation any stamp duty on any nomination or sub-sale, any special stamp duty, any buyer's stamp duty and any penalty, interest and surcharge, etc. for late payment of any stamp duty) will be borne by the Purchaser.

**(4)(vi) 買方須為就買賣的指明住宅物業簽立任何文件而支付的費用**

**Any charges that are payable by a purchaser for execution of any document in relation to the sale and purchase of a specified residential property**

草擬、登記及完成大廈公契及管理合約費用及附於公契之圖則之費用的適當分攤、業權文件認正副本之費用、住宅物業的買賣合約及轉讓契之圖則費、為申請豁免買家印花稅及/或從價印花稅較高稅率(第 1 標準)而須作出的任何法定聲明的費用、住宅物業按揭(如有)及附加合約(如有)之法律費用及實際支出、其他有關所購住宅物業的買賣的文件的所有法律及其他實際支出等，均由買方負責。

The Purchaser shall solely bear and pay a due proportion of the costs for the preparation, registration and completion of the Deed of Mutual Covenant incorporating Management Agreement ("DMC") and the plans to be attached to the DMC, all costs for preparing certified copies of title deeds and documents of the residential property, all plan fees for plans to be annexed to the Agreement for Sale and Purchase and the Assignment, the costs of any statutory declaration required for application for exemption of buyer's stamp duty and/or



higher rates (Scale 1) of ad valorem stamp duty, all legal and other costs and disbursements in respect of any Mortgage (if any) and Supplemental Agreement (if any) in respect of the residential property, and all other legal cost and charges of any other documents relating to the sale and purchase of the residential property.

- (4)(v) 如買方希望更改付款計劃而須更新成交紀錄冊內的記錄，可於不早於簽署買賣合約後 30 日但不遲於買賣合約內訂明的付清 成交金額餘額之日前 30 日透過如此聘用的人向賣方提出申請，並須承擔有關律師費用及雜費(如有)。對前述更改之申請及申請條件的批准與否，視乎有關付款計劃、折扣、贈品、財務優惠或利益的有效性和賣方的最終決定。

If the Purchaser wishes to change the payment plan which requires update to the entry(ies) in the Register of Transactions, the Purchaser can apply to the Vendor through the Person-so-engaged for such change not earlier than 30 days after the date of signing of the Agreement for Sale and Purchase but not later than 30 days before the date of settlement of the balance of Transaction Price as specified in the Agreement for Sale and Purchase and bear all related solicitor's cost and disbursements (if any). The approval or disapproval of the aforesaid application for change and the application conditions are subject to the availability of the relevant payment plan(s), discount(s), gift(s), financial advantage(s) or benefit(s) and the final decision of the Vendor.
